

FINANCIAL REPORT 2022

Executive summary

- The year 2022 was marked by the increase in the volumes of agricultural products exported from the Republic of Moldova and the reduction of commercial margins in the context of the increase in logistics costs;
- The company's sales revenues in 2022 amounted to 1,003.5 million lei, up 2.7 times compared to the previous year;
- The company's gross profit in 2022 was 81.3 million lei, 3.1 times more than the previous year;
- The company ended 2022 with a net profit of 14.2 million lei, with a RoE of 5.2%;
- Total assets as of December 31, 2022 amounted to 378.4 million lei, up 1.7 times compared to the end of the previous year in the context of the revaluation of tangible assets and optimization of the structure of current assets;
- Equity on December 31, 2022 amounted to 271.4 million lei, up 6.2 times compared to the previous year due to the profit obtained and the formation of reserves from the revaluation of assets.
